

[1] Rates: All prices are quoted in US Dollars. Rates are Per Person, Based on Double Occupancy. Rates are for your Cruise Only on this select sailing, and for specific stateroom categories, which are capacity controlled. Government taxes and fees are additional at \$109.24 per person. These taxes and fees may increase at any time up until your day of departure (even after you have paid your reservation in full.) Certain restrictions apply. This offer may not be combinable with any other promotion and may be withdrawn at any time. All itineraries and prices are subject to change without notice. Single Occupancy rates are twice that of the double occupancy rates. Call for rates for a 3rd & 4th Passengers. Not all staterooms & categories can accommodate more than 2 passengers. Rates for passengers 1 & 2 may change if you add a 3rd or 4th passenger to the stateroom, as you may need to upgrade to a category that can accommodate a 3rd or 4th passenger.
